



Former Head of Energy Information Administration Joins Board of Trustees of EPRINC

WASHINGTON, D.C. - Nov. 12, 2008 - Mr. Guy Caruso, who recently retired as Administrator of the Energy Information Administration, has accepted an appointment to the Board of Trustees of the Energy Policy Research Foundation, Inc. (EPRINC) in Washington, D.C. Lucian Pugliaresi, President of EPRINC, commented on the appointment,

In February 2002, President Bush nominated Guy F. Caruso to the position of Administrator of the Energy Information Administration (EIA), a statistical agency within the United States Department of Energy (DOE) that provides policy-independent data, forecasts, and analyses regarding energy. In October 2008, Mr. Caruso retired from government service and his position at EIA and currently serves as a senior advisor at the Center for Strategic and International Studies (CSIS) in Washington, D.C.

Before joining EIA, Mr. Caruso was also the Director of the National Energy Strategy (NES) project for the United States Energy Association (USEA). During this time, Mr. Caruso spearheaded the USEA publication "Toward a National Energy Strategy," which was released in February 2001 and a follow-up study entitled, "National Energy Strategy Post 9/11" which was released in July 2002.

Mr. Caruso has a distinguished record of public service in energy policy both in and out of government. He has worked at the Paris-based International Energy Agency (IEA), first as the Head of the Oil Industry Division where he was responsible for analyzing world oil supply/demand and developments in the oil industry; and later, as Director of the Office of non-members Countries where he directed studies of energy-related developments.

EPRINC was incorporated in 1944 in New York and is a not-for-profit organization that studies energy economics with special emphasis on oil. It moved from New York to Washington, D.C. in 2007. It is known internationally for providing objective analysis of energy issues. It also provides analysis for quotation and background information to the media. EPRINC has been called on to testify before every session of Congress in the last



decade. The Foundation briefs government officials, public groups, legislators, and provides written background materials on request.
